Huntting, Peter L. SAN DIEGO -- Peter was born on October 25, 1945 in Passaic, NJ and unexpectedly passed away on December 5, 2014. He is survived by his wife Christine of 32 years, sister Noel Kelley of Rehoboth Beach, DE, and brother, David Huntting of Rockford, IL. He received a BS degree from Baldwin Wallace University in 1967 and commenced U.S. Navy flight training in Pensacola, FL the same year. He served as a U.S. Navy pilot for seven years and was a veteran of the Vietnam conflict. Following his service, he began a career in pension services and later founded a successful boutique pension services company which has been in operation in San Diego for nearly 40 years. He and Christine enjoyed a life of travel, golf, skiing, attending arts events and reaching out to those in need. He supported multiple programs for underprivileged children and was passionate for America's wounded veterans. December 2014 Hot Topics

New Cumulative List for Plan Qualification Requirements

The IRS recently issued guidance that includes the 2014 cumulative list of changes in plan qualification requirements for individually designed plans. The notice is IRS Notice 2014-77 and the IRS will start accepting applications on February 1, 2015. The cumulative list contains changes under variety of laws notably including the Highway and Transportation Funding Act of 2014 (HATFA), the Cooperative and Small Employer Charity Pension Flexibility Act (CSEC Act), the American Taxpayer Relief Act of 2012, and the Pension Protection Act.

Supreme Court Agrees to Hear A Second Challenge to the Affordable Care Act


The U.S. Supreme Court announced in late 2014 that it will consider an appeal challenging the tax subsidies of the Affordable Care Act. The four cases that are being appealed are *King v. Burwell, Halbig v. Burwell, Pruitt v. Burwell,* and *Indiana v. IRS*. If you recall, the Supreme Court heard a challenge to the Affordable Care Act almost two years ago. Now the Supreme Court will hear a more nuanced appeal regarding the portion of the law providing that people will get a tax credit if they enroll in a healthcare exchange "established by the states." The issue is that only 36 states have established an online exchange for purchasing health insurance. The issue is whether the Affordable Care Act is unconstitutional as written because the other states arguably do not have an exchanged "established by the states."

The states that do not have exchanges have left the job of setting up an exchange to the federal government, as the law permits. The question is whether people can collect the tax subsidies if they buy policies on the federal exchange when the Affordable Care Act describes the exchange as "established by the states."

Under guidance issued by the Internal Revenue Service, at 26 C.F.R. 1.36B-2(a)(1), consumers can claim the tax credits no matter where they live. Thus, the IRS is permitting individuals to claim the tax credits even if they are in a state that uses the federal exchange. The Obama administration has stated that the IRS approach is consistent with the law's aims.
